# **Second Call**

Plans are now being completed for the 2018 Eastern Regional Meeting scheduled for June 4-6, 2018 at the Grand Hyatt Atlanta in Buckhead, Atlanta, Georgia. The program is being organized by Vipin Varma and NCASI Member Coordinators with guidance from the Southern and Northern Regional Committees.

### Why Attend NCASI Regional Meetings?

NCASI Regional Meetings are a "must-attend" for mill, forest landowner, and corporate environmental professionals, regardless of job experience. These meetings are the primary forums connecting NCASI technical studies to real-time issues impacting facilities and working forests. The workshops and technical sessions (a) link NCASI studies to ongoing regulatory, permitting and compliance requirements, (b) discuss environmental topics that impact forest management, mill processes, control devices and wastewater treatment operations and (c) provide information that will improve air emission, effluent and forest management programs. Meeting attendees can leverage these learnings toward solving operational issues. Regional Meetings also serve to highlight the breadth and depth of NCASI expertise and resources available to Member Companies. Participation by member companies, sustaining members, regulatory agencies and university personnel helps advance a common/collective understanding of key technical and regulatory issues.

## 2018 is NCASI's 75-year Anniversary!

We are proud to announce that NCASI turns 75 in 2018. The 2018 Regional Meetings will celebrate this significant milestone and the combined accomplishments of industry environmental leaders and NCASI staff over the past 75 years. It is NCASI's goal to have every Member operating facility represented at one of the Regional Meetings and celebrations. Please help us achieve this goal!

### The Program

Three workshops are planned for the morning of June 4. On Air topics, a two-hour workshop on Air Pollution Control Device Fundamentals, Operations, and Regulatory Requirements is being developed. Concurrently, a Water workshop on Important Considerations when Renewing NPDES Permits is being planned. This 2-hour workshop will provide a review of technical aspects associated with renewal of NPDES permits. Topics will include pre-application effluent testing, calculation of effluent limits based on mill production and "reasonable potential" analysis, certification, effluent monitoring frequencies, and others. A 60-75 min combined workshop on How to Best Leverage NCASI Technical Resources is also planned. This session will serve as a primer for new-to-role environmental staff at the mill-level and a refresher course for experienced staff.

The **General Session** on the afternoon of Monday, June 4 will feature a keynote speech by Mr. Christian Fischer, President and CEO, Georgia-Pacific. The session will also include summary perspectives of NCASI's contributions over 75 years and cover topics of general interest such as industry performance and benchmarking.

The Water Quality Technical Session on June 5 will summarize key regulatory activities at the federal and state level including water quality criteria developments, matters related to fecal indicator bacteria and whole effluent bioassay testing, ASB operations, and current topics in nutrient management.

The **Wood Products Technical Session** on June 5 will focus on the PCWP MACT II and RTR process and discuss NCASI activities related to this rulemaking, case studies on overcoming permitting challenges, and emissions measurement and estimation issues of interest to the wood products sector.

The **Forestry Technical Session** on June 5 will focus on conservation of at-risk species in working forests and related research in the Eastern US.

The **Sustainable Manufacturing and Climate Session** on June 5 will include presentations on an array of trending sustainability concepts such as the "circular economy" and opportunities for beneficial use, the valuation of "natural capital," and big data in sustainability. Presentations will focus on the relevance of these trends for the forest products sector, particularly in the context of customer expectations on sustainable manufacturing.

The two **Air Quality Technical Sessions** on June 5 and 6 will address both ongoing and upcoming regulatory developments, EPA activities on NSR reform, characteristics of performance data reported through EPA's electronic reporting tool (ERT), novel approaches to characterize PM<sub>2.5</sub> emissions and recent NCASI work on PM<sub>2.5</sub> measurement methods. A panel discussion with state regulators, focusing on regional permitting activities, will be featured during one of the sessions.

Those with Professional Engineering or other certifications should note that NCASI is an approved Continuing Professional Competency sponsor and can offer professional development credits to those attending this event.
