Transportation

If flying into Atlanta, you can board the Metropolitan Atlanta Rapid Transit Authority (MARTA) train within the airport. Train fare is \$2.50. Service runs from 4:45 a.m. - 1:00 a.m. on weekdays and 6:00 a.m. -1:00 a.m. on weekends. Trains depart every 10 minutes weekdays and every 15 minutes on weekends. From the airport, take the Northbound train (Red Line - N to North Springs). Exit at the Buckhead Station N7 onto Peachtree Road S. The hotel is two blocks away.

If you are traveling from the Airport at night (after 8:30 pm), take the Gold Line and switch to the Red Line at Lindbergh Center.
